After Round 1, no option has 50% and #4.2 has least votes so it's eliminated.

Anyone who had #4.2 as 1st choice now gets their 2nd choice counted as their vote. 1 Vote is reallocated into option #4.1, 2 votes for #4.4.

After Round 2, #4.6 has the lowest votes and is eliminated. 2nd choice votes are reallocated, and new option totals are noted in above "3rd Round" column, along with corresponding percentage. The percentage is calculated as the new total number of votes for that option, divided by total # of votes which stays at 277.

After Round 3, #4.4 is eliminated. 2nd and/or 3rd choice votes are reallocated based on their votes. New

totals are calculated, and those new totals are shown as a percentage of total votes (277).

When a all three of a voter's options are eliminated, their vote no longer counts towards the total number of votes, thus reducing the total number at which the percentage is calculated. In Round 4, one person's 1st, 2nd and 3rd choice options were eliminated, making the total percentage calculated based on 276 votes.

After Round 4, #4.8 was eliminated and another voter's options have been exhausted. New total is 275.

In Round 5, #4.1 is eliminated and 23 votes reallocated with 2 votes exhausted. New total is 273.

Round 6, #4.3 is eliminated. 27 votes reallocated with 6 more votes exhausted. New total 267 and only 4 options remain.

Round 7, Option #10 is eliminated. New total after reallocation and exhaustion is 256 with 3 options remaining.

Round 8, Option #4.9 is eliminated. After tabulating a few votes including reallocation and exhaustion, Option #4.7 (Queen Street) reached 50% of the total. The tipping point was hit when this option reached 126 of a total of 254 votes counted. The results were no longer tabulated after it was determined that Queen Street reached 50% of the votes.
