WHAT IS PRO KIDS?

Positive Recreation Opportunities for Kids

A program that provides financial assistance to children and youth from the Town of Lunenburg who, due to lack of funds, are not able to participate in sport, recreation, arts, and cultural activities.

WHO IS ELIGIBLE?

Children and youth aged 18 and under who live within the Town of Lunenburg, and cannot afford the costs associated with recreational programs and activities.

BENEFITS OF PRO KIDS

- Gives kids in the Town of Lunenburg an opportunity to participate, rather than watching from the sidelines
- Builds confidence
- Promotes physical activity
- Improves health (mental and physical)
- Builds leadership skills
- Builds self-esteem
- Develops friendships
- Provides the opportunity to be part of a team



PROGRAM GUIDELINES

1. Recipients must be 0-18 years of age, live in the Town of Lunenburg and, due to lack of funds, are unable to participate in sport, recreation, arts, and culture activities.

2. Applicants can apply for assistance with registration fees at any time of year, but approval will only be considered once per season (4x year).

3. Recipients must be registered with an organized community group or recognized program in order to receive financial assistance.

4. Applicants must fill out an application form and submit the completed form to the Recreation Office *at least 3 weeks prior to the start of the program being applied for*. PRO Kids can support a maximum of \$300 per season per child.

5. Approval is based on a reference check. A reference must be familiar with the applicant's personal and financial situation, who can verify that they require financial assistance from PRO Kids. This person should be an adult (not a relative or friend) who knows the family. (Example: Social Worker, Clergy, Group Leader, Coach, Teacher, Doctor).

6. The Recreation Manager may also request the parent or guardian's CRA Notice of Assessment, submitted from the most recent year, to further evaluate an application.

7. Cheques for registration fees will be made payable to the organization where the child is registered.

8. The applicant will be contacted if any further information is required. Applicants should hear the results of their application within 3 weeks of applying.
